On behalf of the Orwell - Grand Valley Chamber of Commerce and the Grand Valley Festival Committee, we would like to extend an invitation to individuals and/or organizations interested in maintaining booth at our 2010 Grand Valley Festival. Festival dates this year are: August 20 th, 21 st. and 22 nd. The festival grounds are located at 78 East Main (behind the Orwell Police Department).

Applications will be accepted on a first-come basis, with preference given to previous festival participants. The dead line for applications is **August 1, 2010**. Your application must be accompanied by check or money order for the full amount or fifty (50) percent deposit per space. All fees are non-refundable, unless the application is denied.

Vendors are requested to set up on Thursday evening, August 19 th., or if not possible, before noon on Friday, August 20 th. Vendors must vacate the festival "grounds" on/or before noon on Monday, August 23 rd. The festival committee will have members on the grounds during the operating hours of the festival. Festival grounds will be open to the public on Friday at 5:00 PM and on Saturday and Sunday at 11:00 AM.

Rates: **Booth Space** is \$50.00 for Non-Profit Organizations, does not include electricity of water hook-ups. The depth of most spaces is 12 - 14 feet. It is your responsibility to determine the exact frontage feet you will require. Additional footage will not be added to the space you request. It is difficult, if not impossible, to obtain additional space once assignments have been made.

Electrical Hook -Up is \$10.00 for each 110 volt 20 amp hook up and \$20.00 for each 220 volt 30 or 50 amp hook up.

Water Hook-Up- is an additional \$10.00.

These prices are for vending trailers, campers and booths. Extra connections will be the same price, as listed above. The contract with the ride company gives them exclusive rights to sell hot dogs, french fries, polish sausage, candy apples, cotton candy, caramel apples and snow cones.
